

# DIABETES & METABOLISM

## Instructions to authors

“*Diabetes & Metabolism*” publishes studies on diabetes, metabolism or nutrition. We only consider contributions submitted in English, and presented according to the “Instructions to authors”.

Contributions may be submitted in the form of:

- Original articles which should not exceed 5 000 words, including tables and figures (500 words each) and maximum 40 references
- Review papers, which are usually solicited by the editors. They should not exceed 7 500 words, including tables and figures (each counts 500 words) and maximum 120 references
- Letters to the editor, which should not exceed 1 000 words, and 10 references
- Rapid communications regarding observations of particular importance. Acceptability will be decided within 2 weeks. Rapid communications should not exceed 1 500 words plus one table, and 15 references
- Editorials, which are usually solicited by the editors, should not exceed 1 500 words plus one table, and 15 references

### SUBMISSION OF MANUSCRIPTS

#### - Submitting an article via Internet

##### Technical requirements

- For PC Windows: NT 4, 2000, XP, Internet Explorer 5.5 and later, Netscape 7 and later, Firefox 0.9 and later, Opera 7.51 and later, Adobe Acrobat Reader 6.0 or later (download free at: <http://www.adobe.fr/products/acrobat/readstep2.html>)
- For Macintosh/Macintosh: 9.x OS X, Internet Explorer 5.x and later, Netscape 7 and later, Firefox 1.0 and later, Safari 1.0 and later, Opera 7 and later, Adobe Acrobat Reader 6.0 or later (download free at: <http://www.adobe.fr/products/acrobat/readstep2.html>) MS Word and Wordperfect can be used for text files.

##### Brief overview of the EES system

- New users can access the home page of the *Diabetes & Metabolism* at the following address <http://ees.elsevier.com/diabet/>
- Click on “register” at the top of the screen and fill in the required information: “first name”, “last name” and “e-mail address” Then fill in the required fields: title, preferred contact mode, country, other address, preferred user name. You will receive rapid confirmation of your registration together with your “username” and “password” by e-mail.
- Registration is required only once on your first visit. On subsequent occasions, you only need to click on “login”, then on “author login” to access the system directly.
  - Once you have been identified and have entered the system, if you wish to submit a manuscript, follow the instructions on the screen and enter the different details required for submissions and then download your files.

A single file is required for:

- The title page, the manuscript, the text, the tables and the legend of the figures (refer to presentation of manuscripts).
- The figures: (diagrams, drawings, and color or black and white photos) should always be submitted in individual files i.e. only one figure per file or one compressed folder (.zip) with one file per figure. #### - Submitting an article by e-mail

Please respect the procedure described below when submitting your manuscript by e-mail:

- Submission of an article: give its title and attach as described below in individual files:
  - The manuscript: Only one file should be used for the manuscript (see presentation of the manuscripts) including the title in English and in French, the names of the authors and their affiliation/address, the summary in English and in French, the key words in English and in French, the text, the tables with legends, and the legends of figures in English.
  - The figures: (diagrams, drawings, and color or black and white photos) should always be submitted in individual files i.e. only one figure in each file.

### PRESENTATION OF MANUSCRIPTS

The covering letter must provide the address, telephone and fax number as well as the e-mail address of the corresponding author. It must include the following statement signed by all authors: “*We approve the submission of this paper to “Diabetes & Metabolism” for publication. We confirm that neither the manuscript submitted nor any part of it has been published or is being considered for publication elsewhere (abstracts < 300 words excepted). We confirm that the paper has been read and approved by all authors.*”

- Microsoft Word must be used. Type manuscripts with Times New Roman Font, 1 1/2 interval, character 12.
- The title page should contain: a) title without abbreviations; b) initials of first and middle name, and last name of each author in upper case; c) name and address of department(s) and institution( s); if several institutions are involved, they must be identified with the corresponding author(s) by an **alphabetic letter** in exponent; d) a short running title of no more than 40 characters; e) address, e-mail, phone and fax number of the corresponding author.
- Provide a summary which must not be longer than 250 words. This summary should consist of four paragraphs, labeled: **Aim, Methods, Results, Conclusion.**
- Provide up to five keywords at the end of the summary.
- Title, structured summary and key-words in French should be also provided.
- Number references in brackets consecutively in the order in which they are first mentioned in the text. References first cited in the legend of a table or a figure should be numbered in accordance with a sequence established by the first identification in the text of the particular table or figure. Articles in press may be quoted (designate the journal and add “in press” in parentheses), but a copy of the manuscript must be provided.
- Use the style of samples given below, according to Vancouver style. For detailed information see: Lancet 1979;1:428–31.
  - Standard Journal Article (List all authors when six or less; when seven or more, list only first six and add et al.)

  - Abstract in a journal supplement - “Abstract” must be mentioned into brackets at the end of the title, and the volume number must be followed by (suppl).

- Chapter in a book (the authors are the editors)

- Chapter in a book (the authors are not be the editors)

- Abbreviations should be given in following format: OGTTS, oral glucose tolerance test. If necessary, a table listing the main abbreviations should be provided.

- Conflicts of interest (relevant to subject of the article) should be mentioned.

## CONFLICT OF INTEREST

In accordance with international practices concerning conflicts of interest, all submitted manuscripts must be accompanied by a declaration of conflict of interest.

A conflict of interest exists when an author or co-author has financial or personal interests with other persons or organisations that may influence his professional judgement concerning an essential factor (such as a patient's wellbeing or integrity of the research). The main conflicts of interest include financial interests, clinical trials, occasional business involvements and family connections.

**All authors** of the publication **must declare all of the relationships they have had** during the past 3 years that might be considered to have a potential conflict of interest **but only in connection to the published article**.

**General rules (for journals not included in Elsevier Electronic Submission system EES):**

1. **Where there is no conflict of interest in connection to the submitted article**, the following declaration should be added to the end of the report: No potential conflict of interest relevant to this article was reported.

2. **Where there is a conflict of interest in connection to the submitted article**, fill in the declaration available from one of our websites. Every co-author must submit a completed declaration with the submitted manuscript.

For example, the following statement would be inserted at the end of the article:

*Conflict of interest: C.R. Occasional involvements: advisory services: Company X; E.L. Financial interests in a company: Company Y; J.-J.E. Clinical trials: as main investigator or study coordinator*

3. **Where no conflict of interest in connection to the submitted article has been sent** by the author (or co-authors), the following statement will be added to the published article: **Conflict of interest: the authors have not declared any conflicts of interest.**

## EES RULES

On submitting a manuscript electronically *via* EES, the completed declaration(s) must be included with the other components of the submitted article.

When the document(s) has not been sent along with the submitted manuscript, the following statement will be added to the published article: **Conflict of interest: the authors have not declared any conflicts of interest.**

When the article is considered as suitable for publication but with appropriate revisions, authors must resubmit a revised manuscript within two months.

Once the article is accepted for publication, all figures are professionally drawn by the Journal, and sent by mail to authors for immediate (return of mail) checking.

## PRODUCTION, CORRECTION OF PROOFS, REQUESTS FOR REPRODUCTION

In the case of partial or complete reproduction in the manuscript of a document or an illustration that has already been published elsewhere, the written authorization of the author or authors is required.

When a manuscript that has been accepted for publication goes into production, the publisher will send the corresponding author by e-mail a formula for the transfer of copyright, which should be completed and signed by the author responsible for the article on behalf of all the authors and then returned to the publisher as rapidly as possible. The author will receive an order form if he wants to order additional offprints. In addition of his PDF file of his published article.

The corresponding author will receive the electronic proofs of the article in PDF format or by ordinary mail if necessary. Corrections are limited to typographical errors. Authors are responsible for returning the corrected proofs to the publisher within 48 hours of reception at all times of the year. In the case of delay, the publisher reserves the right to start printing without the author's corrections.

After publication, all requests for reproduction should be addressed to the publisher.
